

1 AGREEMENT ON TERMS AND CONDITIONS (OWNERS)

To gain ownership and obtain access to DTU's SharePoint site I hereby declare that I agree with the following terms and conditions:

In order to ensure confidentiality DTU's Legal and Contracts unit can provide you with relevant templates on confidentiality agreements. Please notice that you are not allowed to share files subject to confidentiality towards parties not members of this site.
6. The joint sharing and modification of files on this site do not entail any transfer of ownership or any other right of exploitation.
7. I accept that DTU has no liability whatsoever in the event of loss of documents, data and shared files related to this site.
8. I accept that DTU has no liability for any loss of production, consequential loss, loss of profit or other indirect loss, related to the use or misuse of this site.

This agreement is governed by Danish law, with the exception of international private law and conflict of law rules, to the extent that such rules would result in the application of another country's law.

Any dispute arising between the parties in connection with this agreement, including its interpretation and use, which cannot be settled amicably by negotiation between the parties, shall be settled by the Court of Lyngby, as the court of first instance.
